

2017 Four States Limousin Spring Sale Entry Form

I wish to enter ___ lots in the Four States Limousin Spring Sale.

List below the number of entries per category and enclose your entry fees, registration papers, current performance records (EPD's), A.I. dates/and or pasture exposure dates, service sires and their registration numbers and footnotes for cataloging purposes.

All cattle must be either solid red or solid black in color.

___ **Cow-Calf Pairs** (Fullblood, Purebred and Lim-Flex) with calves at side. Calves with fall calves must be bred back and at least 60 days safe in calf by sale day. Cows must be born after 1.01.09

___ **Bred Cows** (Fullblood, Purebred and Lim-Flex) Must be at least 60 days safe in calf by sale day. Females must be born after 1.01.09

___ **Bred Heifers** (Fullblood, Purebred and Lim-Flex) Heifers must be born to calve by 30 months of age. All heifers over 15 months of age sale day must be at least 60 days safe in calf.

___ **Open Heifers** (Fullblood, Purebred and Lim-Flex) Must be open and broke to lead and able to be displayed on the halter.

___ **Bulls** (Fullblood, Purebred, Lim-Flex) Must be 12 months to 24 months of age to sell and the must meet the following requirements to sell; -Must be tested for Trich to be sold in this sale and then to go across the state lines -Birthweight EPD must be 3.5 or less

-Actual birthweight must be 100# or less -Must have a minimum actual weaning weight of 550# -Must have a minimum yearling weight of 1000# -Must pass a certified veterinary semen test -Must has a minimum yearling scrotal measurement of 32 cm

___ **Embryos** (Fullblood, Purebred and Lim-Flex) If you consign embryos to the sale then it will be the responsibility of the buyer to pay for the shipping of the embryos. If you want to have them on hand sale day then that is fine as well.

___ **Planned matings** (Any breed can be sold as a recipient at any age) The mating must be Fullblood, Purebred and Lim-Flex) The mating needs to be bred at least 60 days.

*Please make note that if you enter cattle in the sale and then scratch them from the sale after the catalog has went to press you will forfeit your entry fee. You may substitute an animal of like kind to replace it if it meets all the above requirements.

Original registration papers *If you are selling embryos please fill out the frozen embryo transfer paper and send it in with entries A.I. dates and/or pasture exposure dates Service sire name and registration number Complete footnotes
